Al-Quran as a guide for human life, provides sharia guidelines for entrepreneurs to work (Bahri, 2018) In Islam, the goal of creating jinn and humans is to solely serve/worship Allah the Creator (Qs.51:56). If you pay attention to the verse, it contains the sentence "Ya'budun", if translated into Indonesian it means; "serve or serve". According to the Ulama the sentence "Ya'budun" with the meaning of worship has 2 (two) meanings. First, Mahdhah Worship, namely the relationship between humans and Allah whose procedures have been regulated in the Qur'an and the Sunnah of the Prophet such as Prayer, Fasting, Zakat and Hajj, while the second is called the Ghairu Mahdhah worship, namely all forms of actions related to fellow human beings, such as hospitality, helping and buying and selling or entrepreneurship, and so on. If we take the second meaning of the sentence "Ya'budun", this means that Islam categorizes every good deed/word, what we do in this life can be classified as worship, therefore Islam gives direction that religion is not only the goal of achieving the afterlife, but there needs to be a balance between this world and the hereafter, this is what Allah explains in the Qur'an (Qs.28:77):

Meaning: And seek what Allah has bestowed upon you (happiness) in the hereafter, and do not forget your share of the worldly (pleasures) and do good (to others) as Allah has done good to you, and do not do mischief in (face) of the earth. Verily, Allah does not like those who do mischief.

Al-Qur'an is a holy book that gives instructions to the right path, gives good news to Muslims who teach good deeds. Meanwhile, good faith or good intentions can be seen when the seller says the right and honest things about his merchandise. A good Muslim can be seen from his daily behavior.

The behavior of a Muslim in doing business is needed as an investment that can be profitable and guarantee his life in this world and the hereafter. the Koran'an and hadith are guidelines for a person's behavior by aligning his behavior with the behavior of the Prophet. The business behavior of a Muslim entrepreneur can be seen from their piety, the trustworthiness they have, their kindness, the way they serve their customers in a friendly manner, and all their business activities are only done for worship.

Behaving well by applying polite and courteous behavior will make consumers comfortable and happy. Good behavior can also be reflected in the character of the person. Morals are someone's behavior that is done repeatedly without thinking. A Muslim can be seen to have good morals when all of his activities always remember Allah, enjoy doing good, leave useless things, istiqamah.

What is called good morals in doing business is done by doing business with halal commodities and serving buyers or customers in a good way with polite words and friendly greetings. Good deeds must be done during business activities and daily activities. Serve well. In addition, Muslim entrepreneurs must also be humble, namely serving well. Buyers will feel happy if served in a friendly and kind. Provide a grace period when the buyer has not been able to pay the shortfall or pay off the loan. bought goods and the right of khiyar does not exist, a feeling of regret and resentment will arise between the seller and the buyer. So in buying and selling, khiyar is included in Islamic business ethics to protect human relations from evil.

Be generous with buyers by providing a deferment of payments. Deferral of payment is given to help fellow human beings who are in an unfavorable condition from an economic point of view. Giving goods for free is done if the buyer is deemed unable.

e. Work as worship

Humans have the ability to carry out activities using the power they have. Allah SWT has given these four powers in terms of human ability, thinking power, physical strength, heart power, and life force. With his ability, humans can use these four powers to fulfill their life needs by working. Worship itself must be done by someone to do things that are ordered and prohibited by Allah SWT. Work as worship is done to meet needs in a good way. In a good way and in accordance with existing sharia guidelines. Because everything we do in the world will be held accountable at the end of the day.
